Catholic), Bloomington (Cornerstone Christian Academy), Bloomington (H.S.), Fairbury (Prairie Central), Farmer City (Blue Ridge) [Coop], LeRoy, Lexington, Normal (Community), Rantoul

**Check in time/location:** 6:30 a.m.

**Fishing times:** 7:30 a.m. – 3:00 p.m. All regionals and sectionals will be set for at

least five (5) hours of fishing and cannot exceed eight (8) hours on the water. They might have to be varied because of weather. It is considered a complete tournament if 2 ½ hours of fishing occurred at the regional/sectional tournament. If the tournament is postponed until the next Monday, no fish caught on the original date (Thursday) will count towards the tournament weigh-in on the make-up date. All boats must be back in the designated weigh in area by the appointed end of fishing time, or a boat may be

penalized according to the Terms and Conditions.

**Rosters:** To be turned in at check in – (A Team Roster Form is included the bass

fishing manual downloadable on the IHSA website). Please remember,

principal's signature must be on form.

Safety check: All boats must meet the safety check as designated by the State. (See

attached list of what is needed to pass this safety check.)

**Equipment check:** All coaches and participants must wear a coast guard approved life

jacket and protective eye wear the entire time on the boat.

**Lake restrictions:** List of all lake restrictions for all regionals and sectionals is included.

Please review the restrictions for your assigned lake at the bottom of

this sheet. (Such as motor restrictions, no fish areas, etc.)

**Limits:** Each boat must have a bump board and no fish under 12 inches may be

kept.

Only 5 fish may be in the live well at any one time in the boat. The five fish limit applies to the team on that boat. The participants may release one fish to replace it with a larger one, if they have met the 5 fish limit. All fish must be kept alive. No dead fish may be culled. Penalty will be assessed for any dead fish. (See Bass Fishing Terms and

Conditions.)

**Communication:** All boats are required to have a cell phone and must provide the

tournament manager the number of that cell phone in case of an

emergency or bad weather conditions.

**Uniforms:** School uniforms can only have the school name and/or logo and the

student's name on them. Any sponsorship the school has secured cannot be displayed on the student's uniforms or on the coach/driver of the boat. Sponsorship logos may be displayed on the boats that are

in the tournament.

**License:** All participants must have a current Illinois fishing license unless they

are under the age of 16.

**Pre- fish at Regionals** 

& Sectionals:

There is no limit on how many times you pre-fish regional/sectional lake. Please make sure you have contacted the regional or sectional lake contact person to make any necessary arrangements. Any costs associated with pre-fishing are the responsibility of the school or

angler(s).

**Awards:** A plaque will be presented to the winning team and medallions will be

presented to the team boat that caught the largest bass.

**Sectional:** The top six boats will advance to the sectional at Clinton Lake on May

22, 2025.

**Boat Ramp:** The ramp is adjacent to the water treatment plant at the north end of

the lake near the dam.

**Restrictions:** There is a 40hp limit on the lake. Motors greater than 40hp will be

allowed at no wake speed only. The lake permit fees will be waived, but a form needs to be completed each day you are there. Please write IHSA across the form and place in the box at the permit office. Also, have a small sign on your dash saying "IHSA Competitor" on it.

The Alabama Rig, or other multiple rig variations, is prohibited during

any IHSA Bass Fishing State Series competition.
