

WAIVER, INDEMNITY AND RELEASE OF LIABILITY

I understand that while participating in the IHSA Road Race ("the Event") that I will be using public streets and facilities where many hazards exist, and I am aware of and appreciate the risks that may result. I am also aware that accidents may occur during the Event which could result in serious injury or death. I am voluntarily participating in the Event with knowledge of all such risks. I will read the rules for participation in the Event, and I will abide by all rules and regulations established by the event organizers and personnel. I further agree and understand that no strollers, dogs or other pets (other than service animals), or head phones will be allowed during the Event. In consideration of the acceptance of my registration entry for the Event, I assume full and complete responsibility for any injury or accident which may occur during my participation in the Event, and I HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS THE ILLINOIS HIGH SCHOOL ASSOCIATION, HEARTLAND COMMUNITY COLLEGE AND ITS BOARD OF TRUSTEES, AND NORMAL PROFESSIONAL BASEBALL, LLC (THE NORMAL CORNBELTERS BASEBALL CLUB), AND THEIR OFFICERS, AGENTS AND/OR EMPLOYEES, AS WELL AS OTHER PERSONS AND ENTITIES ASSOCIATED WITH THE EVENT (ALL INDIVIDUALLY AND COLLECTIVELY KNOWN AS "RELEASEES"), from any and all claims, losses, injuries and liabilities, or damages (collectively, "damages") that I have or may have in the future based upon any acts or omissions, whether known or unknown, relating to, arising out of, or in connection with, the Event, WHETHER SUCH DAMAGES MAY BE CAUSED BY MYSELF OR BY THE NEGLIGENCE, OF ANY DEGREE, OF THE RELEASEES. This agreement may not be modified orally or in writing by any individual. I understand and acknowledge that my participation in the event involves inherent dangers that no amount of care, caution, instruction or expertise could eliminate, and I am knowingly participating in the Event at my own risk. I intend by this Waiver, Indemnity and Release of Liability to release in advance, to waive my rights and to discharge all Releasees (as defined above), from any and all claims, losses or liabilities whatsoever for death, bodily injury or property damage that I may have, or which may hereafter accrue to me, as a result of my participation in the Event, EVEN THOUGH THAT LIABILITY MAY ARISE FROM NEGLIGENCE OR CARELESSNESS ON THE PART OF THE RELEASEES. I understand and agree that this Waiver, Indemnity and Release of Liability is binding on my heirs, assigns and legal representatives.

I am physically capable of completing this Event. I understand that I may be asked to provide a doctor's note or other proof that I am permitted to participate by my primary health care provider. If I am aware of or under treatment for any physical infirmity, ailment or illness, my medical care provider knows of and has approved my participation in this Event. I will maintain personal health insurance while participating in the event. I acknowledge that I, and I alone, am solely responsible for my personal health and safety, and the personal property I bring with me. I consent to treatment in the event of an emergency or other incident in which, in the reasonable judgment of the on-site personnel, I require medical care.

I have carefully read this waiver and release and fully understand its contents. I am aware that by signing this waiver I am agreeing to its terms, including waiving legal rights. Knowing this, I agree to these terms of my own free will.

On behalf of the minor participant, I hereby irrevocably and unconditionally agree to all of the terms of the release and waiver of liability. I also, for myself and on behalf of my heirs, estate, insurers, successors and assigns, hereby release, indemnify and hold harmless the Releasees (defined above), with respect to any and all claims or causes of action I may have for damages for personal or bodily injury, disability, death, loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF ANY OR

ALL OF THE RELEASEES OR OTHERWISE, WHETHER OR NOT NEGLIGENCE HAS BEEN PROVEN, to the fullest extent permitted by law. By signing below, I am agreeing to these terms and conditions, including waiving legal rights.
